After-tax Cost of Education

Canada Revenue Agency considers religious education to be a charitable activity, Redeemer, as a registered charity, is permitted to issue a charitable receipt for the portion that **a Unbe** over and above the *cost of education*. The *cost of education* is the cost of providing the non-religious portion of **YUW** student's education. This number is determined annually, following CRA rules and regulations."
